Introduction:

The following is a risk assessment carried out in preparation for the "Calder Marathon" to be held by Pennine Canoe Club at South Pennine Boat Club(SPBC), Mirfield on Sunday 16th June 2013.

This risk assessment is prepared by Pete Lawton (Pennine Canoe Club Marathon Organiser).

The competitors, spectators and officials will congregate at SPBC, within the compound. The SPBC Jetty will be used for ingress/egress. The Pear Tree Jetty (Public House on the opposite side of the river) will be used as the start/finish point.

All races will start/finish at SPBC/Pear Tree, about 200m upstream of Battyeford Lock.

2-mile races will go downstream, into the Mirfield Cut (through Ledgard Flood Gate) turning just after Bull Bridge (nr.18) and returning to SPBC.

4-mile races will go downstream, into the Mirfield Cut (through Ledgard Flood Gate) turning at Shepley Bridge Lock (by Mirfield Marina) and returning to SPBC.

8-mile races will go downstream, into the Mirfield Cut (through Ledgard Flood Gate) turning at Shepley Bridge Lock (by Mirfield Marina) and returning as far as Battyford Lock, where they will portage into Battyeford Cut. At the end of the cut, they will go through the Flood gate and turn in the river, returning immediately into the cut. This route will then be reversed (Battyeford Lock, Ledgard, Shepley Marina, return to SPBC).

General:

The river level will be monitored prior to the race by checking both the environment agency website and the physical depth marker at Ledgard bridge. We will also check local weather forecasts for potential rainfall.

Pennine Canoe Club members have paddled this stretch of water on a weekly basis for many years and are aware of the variety of the river levels and how it affects the course – and not least that rainfall outside Mirfield can lead to closure of Ledgard Flood Lock. If the Flood Lock is closed, this will reduce the scope of the potential race route (as detailed above). In this situation, we will consider if the river is safe to paddle. If it is, we will alter the course to be one of repeated loops from SPBC, around the old bridge stanchion above the weir and back to SPBC. Suitable safety cover will be placed at the bridge stanchion. If not safe to paddle, the race will be cancelled.

All Race Officials (e.g. marshalls and support/rescue paddlers) will attend the pre-race briefing. Turn marshalls will be provided with copies of the race sheets so that they can count off all boats that are due to pass through their area of responsibility. Marshalls will also have a list of contact mobile telephone numbers so that each is able to contact the other at all times.

Officials and senior club members will carry out an inspection of canoe buoyancy & individual's buoyancy aids to ensure that they are fit for purpose.

At time of writing, Shepley Bridge Lock (Lock Nr.11) at the Marina turn is 'broken' and out of service – and I understand unlikely to be fixed before the event. This will mean that there will only be minimal traffic along the cut. The event date is NOT one of the regular Open Days (with boat trips) that Sheply Marina often hold.

Safety Briefing:

There will be a safety briefing for all paddlers taking place after all competitors have registered. This will take place 15mins before race commencement and will include, but not be limited to, the following:

- Overview of the race route (a plan of which will be on display from start of registration) pointing out any known hazards; landmarks; direction of river flow; river level; turn points; start/finish lines; ingress/egress points.
- o Procedures in event of capsize, or paddler in need of assistance
- o Requirements for paddlers to wear suitable buoyancy aid
- Need to cover cuts/scratches and remind paddlers of the dangers of infections (e.g. leptospirosis)
- Importance of washing hands etc before eating/drinking. (Wet Wipes & Anti-bacterial hand gel will be provided)
- Awareness of where turn marshalls will be and who will be providing safety cover in between (e.g. some safety cover paddlers will wait at perceived hazard areas, while others will follow the younger or less experienced paddlers)
- Pointing out who are the qualified Aquatic First Aiders

Key personnel:

The following persons will hold overall responsibility for the areas detailed in the Known Risks&Hazards table at the end of this document:

- David Jefferies Race Marshalling
- Viv Kendrick Off Water management, First Aid, Timekeeping
- o Martin Haughton Safety Cover

Each of the above are BCU Coaches and Aquatic First Aiders.

In addition, Pete Lawton is responsible for the general organisation and administration of the event.
